Be advised that rental is subject to the following. Conditions as laid down in the Post Office Ordinance
Chapter 145:
85. No one person shall rent a box under an assumed name; nor shall a box be rented to any person where there is a reason to believe that it is to be applied to improper purposes.
86. A box shall not be assigned to more than one person, except in the case of the Firm, Company, Corporation or Society
87. Unless a renter shall give notice in writing to the contrary, all letters directed to him/her, or in his/her care, or to his/her address shall be deposited in his/her box. Registered and unpaid postal packets shall not be placed in a renter's box, but shall be retained for delivery, notice of such packet or registered items shall be given in the form of a receipt placed in the renters box.
88. No correspondence for a box renter shall be delivered over the counter.
89. Should a key be lost, the renter will be required to pay for a new one.
90. The renter of a box will be required to pay for all injuries or damages done to it by himself/herself/ or his/her agents.
91. When it is desired to cease renting a box, the renter shall upon notification to the Postmaster that the use of the box has been discontinued returned the key originally handed to him/her in good order to the Postmaster
92. In the event that any letter or packet being placed in the wrong box either accidentally, or
because of it being wrongly addressed, such a letter or packet shall be immediately be returned to the Post Office. Should the renter, or the holder of the key, of any box fail to comply with this provision, it shall be lawful for the Postmaster to discontinue the use of the box by such box renter or key holder.
